Details of the Structure :

- i) G.I. Tubular Shade Net House (50% shade UV stabilized agro shade net having BIS compliant code IS 16008: 2012) 200 sq. meter Dome shape roofing 8m x 25m x 4.5m x 3m (B x L X CH X SH) with 1 door (2m x 1m), Diameter of the GI pole - 60 mm and
- ii) Providing/Fixing anti insect net (40 to 50 mesh)


Essential/ necessary criteria of the Firm –

- i) The Firms should be Registered & Authorized having its servicing facility Centre at Imphal.
- ii) Proof of Registered office address in the State.
- iii) Should have a valid* GST Certification.
- iv) Copy of PAN Card
- v) Should not be black listed by any Organisation/ Agency/ Body/ Government during the last 10 Years.
- vi) Should have good tracking record and proof of installation of such type of Shed Net House in the Public Sector of the State.
- vii) Income Tax Return for last 3 (three) years
- viii) Duly attested Copy of Bank account details of the Firm.
- ix) Annual Turn Over for last 3 (three) years
- x) Earnest Money for an amount of Rs.96,000/- in form of DD in favour of Manipur State Medicinal Plants Board, Directorate of AYUSH, Lamphelpat.
